6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2075/01/21 (4-May, 2018)** at the Palungtar Municipality, **Gorkha**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
