1. Palungtar Municipality invites sealed bids or electronic bids from eligible bidders for the Construction/Upgrading of Municipal Structures as listed below under the National Competitive Bidding procedures.
(In Case of Contract no. PMUN/GORKHA/01/2074/75, only eligible bidders with the following key qualifications should participate in bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 3,65,00,000.00 (Without VAT).

Minimum Work experience of similar size and nature: One(1) Project with a Value of Nrs. 4,10,00,000.00 (Without VAT).

5. Sealed or electronic bids must be submitted to the office of Palungtar Municipality by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Noon on 2074/12/02 (16-March, 2018). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2074/12/02 (16-March, 2018) at the Palungtar Municipality, Gorkha. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
