1. Palungtar Municipality, Office of the Municipal Executive, Palungtar Gorkha, Nepal invites sealed bids from eligible bidders for the contract name and title as given in 11, under National Competitive Bidding procedure.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Palungtar Municipality Office (Ph – 064400002,9856061111,9856040467) or may visit the E-procurement section of PPMO's website <http://www.bolpatra.gov.np>
3. To purchase the bidding documents, eligible Bidders should write to address above requesting the bidding documents specifying the contract nos. and Title given in clause 11 on or before 17:00 hrs on 2074-01-24 and pay a non-refundable fee for each set as specified in clause 11 in Nepali Rupees, or its equivalent in a free-convertible currency. For the purpose of Bidders who choose to submit their bid electronically through E-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document (as specified in the table below) in Palungtar Municipality's Rajaswa (revenue) section either by direct deposit or by Tele-transfer of deposit in the Palungtar Municipality Office's account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.

Documents received after this deadline will not be accepted.
5. Bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 2074-01-25 at Palungtar Municipality, Office of the Municipal Executive, Palungtar, Gorkha, phone no:- 064-400002,9856061111,9856040467.
6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security for the amount as specified in clause 11 and valid for 30 days beyond bid validity period. If bidder wishes to submit bid security in the form of cash, the cash should be deposited at office bank account, Rastriya Banijya Bank, Gorkha, Account No. 3060304018102 Ga-4-3 and submit the receipt of the deposited amount of cash with the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day.
8. A pre bid meeting will be held on 2074-01-14 at 13.00 hrs at the Palungtar Municipality, Office of the Municipal Executive, Gorkha. The attendance in pre-bid meeting is optional but interested bidders are encouraged to attend the pre-bid meeting.
9. The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever.
10. Any conditions so far not covered shall be as per Public Procurement Act-2063 (Amendment 2073), Public Procurement Regulations-2064 and Local Government Financial Regulations 2064.
